Travis Brown opened the floor to town residents who wanted to speak on behalf of the projects under consideration for CPC funding. Jeremy DaCruz (Resident) spoke on behalf of the Yankee Doodle Bike Path asked the Committee to approve the funding request. John Curran (Town Manager) added that securing the easements is the last hurdle before construction can begin. He stated that whatever that Committee can give is helpful, but he hopes that the CPC would give

deference and priority to town projects over private projects.

### Meeting Format Discussion

The Committee left the Public Meeting open while addressing other items on the agenda. Travis Brown asked Committee members if they want to continue meeting via Zoom only, move to in person only, or have hybrid meetings. There was broad agreement around maintaining at least a remote participation option, though Committee members acknowledged that there is value to meeting in person as well. The consensus was for the Committee to move to hybrid meetings; no decision was made, however. Travis Brown requested Planning Staff investigate room availability to accommodate hybrid meetings in the future.

## Past Project Updates

Jane Merrill presented updates to the Committee on projects approved over the last few years.

- Town Document Preservation Storage is completed.
- The Masonic Lodge First Floor restoration is completed, and the Food Pantry will open in April.
- The Masonic Lodge Façade has a design but there isn't money allocated right now for the construction work.
- The Manning Manse is completed; Planning Staff is working on having a CPC sign displayed in the front yard.
- Travis Brown added that the FCCB came to the HDC; they are still working on the design.
- Matt Battcock will follow up regarding the Maxim Ladder Fire Truck project.

#### Allocation Discussion

Travis Brown began the allocation discussion, stating that he wanted to reserve some of the available money for future projects. He suggested funding the Clara Sexton House for \$69,175, the Bluebird Restoration project for \$3,000, the Middlesex Canal Museum for \$301,000, and the Yankee Doodle Bike Path for \$498,362, leaving \$400,000 in the account. The Committee members largely agreed on this proposal — with Phil Newfell pushing to increase the funding for the Yankee Doodle Bike.
