PUBLIC COMMENT:

Andrew Jennings of 29 Talbot Ave N. Billerica and serves as Billerica's representative on the Lowell Regional Transit Authority Board. Nothing changed, just tightened up a couple of things. Will the garage door look historic and match the house historically? Once the addition is built and livable, they will live in the new portion and rehab the existing area. The existing bathroom is a small bump out area and the roof of it is rotting as shown in the PowerPoint. The commission would like to see a historical looking garage door.
