PHR Skate Park Eligibility

Dave Grubb presented the project eligibility form for the PHR Skate Park. He is seeking roughly \$450,000 in funding. The Committee members agreed that this project is eligible for CPA funding. Paul Watson advised the Committee that they have approximately \$750,000 in funding for the fall and for next spring. While some members were okay with allocating the full amount, most Committee members were hesitant about committing more than half the available funds to one project. Kelley Sardina suggested a few other potential funding sources, and Diane DePaso suggested phasing the project to allow for more time to secure additional funding. Dave Grubb is going to turn in the full application to the Planning Department by July 19th. At the August meeting, the Committee will vote on their funding recommendation and vote on the Warrant Article for Fall Town Meeting.
