Jill Griffith with Sullivan and Gomez presented the project overview using a slide presentation. She summarized the impacts to wetland resource areas, benefits of the project, and the construction approach on how they plan to remove the Talbot Mills Dam located on the Concord River in North Billerica.. Also present were Heather Conkerton with OARS, Ben Gahagan and Joe Holbecke with the Mass Wildlife and Fisheries, and Eric Hutchins with NOAA Restorations Center.

Robert Martin, CRT Manager/Owner, discussed the dam and explained why he would like to have the dam removed due to safety and liability reasons.

Eric Hutchins with NOAA explained that they would leave the water chestnuts instead of removing them. because to remove them would have a huge impact on the wetland. Allowing the natural vegetation to grow through the existing water chestnuts would normally take only one growing season.

There was a lengthy discussion concerning the long-term impacts to wetland resource areas upstream of the dam and the spread of invasive plant species in resource areas and potential impacts to the Town's water supply intake, which is located upstream of the dam. There was also a discussion regarding the need for Peer Review of the NOI, particularly the

proposed short-term construction related impacts and long-term impacts to regulated wetland resource areas after the dam has been removed, the degree of any restoration and an invasive species management plan. Also, the need for engineering peer review of the proposed construction means and methods of dam removal, including the access road proposed within various resource areas, staging and stockpiling locations proposed for the project, and overall project layout. There was also a discussion concerning the potential need for a bond to cover costs associated with the spread and management of invasive plant species.

The Commission noted the following information is missing and/or required as part of the NOI wetlands review.:

- Independent Peer Review is needed, both wetlands review and engineering reviews.
- Addition information concerning the short-term construction impacts and long-term impacts to wetland resource areas around the dam and upstream of the dam, including the large wetland system and river extension between the main river channel and Call Street. As presented, it is not clear
- How will it be confirmed that the area will remain a wetland, since ecological restoration does not exist in the Billerica By-Law.
- > Confirm if property boundaries and jurisdiction of land will be reviewed and documented post dam removal.
- Additional information concerning the superfund site and related drainage, leachate and water levels.

Fred Liberatore, resident of Billerica, spoke on the water system and felt the dam would not fail during a flood. He expressed his opposition of the proposed project.

Marlies Henderson, resident of 31 Sprague Street, discussed the project and the removal of the water chestnuts. She expressed her support of the proposed project.

Andrew Jennings, resident of 29 Talbot Avenue, spoke on the project and felt the Notice of Intent is incomplete and everyone should know of the full impacts of the mitigation, and include the historic aspects and related impacts as well.. He expressed his opposition of the proposed project.

Justin Damon, resident of 429 Middlesex Turnpike, spoke on the project and inquired about the peer review process. He also discussed the historical aspect of the dam and the free flow of the dam.

Elissa Brown, Former Conservation Agent for Concord from 5 Concord Green, in Concord, MA, discussed the historical aspects of the river and inquired about the impacts to fish after the dam removal. She expressed her support of the proposed project.

Tom Lincoln, 27 Gleason Street in Medford, MA, and Chair of the Middlesex Canal Association spoke on the project and its historical aspect. He noted objections to the project and referenced correspondence related to the Section 106 historical review process. The correspondence was from Eric Hutchins with the NOAA, acknowledging additional design details that still need to be defined through the local, state, and federal permitting processes and the additional follow up required under the Section 106 review. He is concerned that the historical significance of the dam is not being considered. There was also discussion regarding a fish ladder option that was a preferred alternative initially, which was a simple and logical alternative, but the response he has received is that it would be too expensive. He expressed his opposition of the proposed project.

Jay Breen, President of the Middlesex Canal spoke on the project and discussed the quantity of fish that pass through the dam, and what would happen if they removed the dam. He feels this will kill fish due to the fact the waters will be too low. He expressed his opposition of the proposed project.

Wayne Smith, a resident of Billerica for 47 years now, discussed the water levels being dropped and the possibility of being added to the MWRA and the related high costs. He expressed his opposition of the proposed project.

Dana Marrett, 24 Wilson Street, noted that he spoke to Jill Griffith prior to the meeting and expressed his concerns related to sewer and water and about his land. Specifically, what would happen to his property including mitigation since the water level will drop drastically, and he will lose the features and characteristics of his property he has known for a very long time.

Ed Bunker, resident of Billerica, spoke on the project and was concerned about the price of his property and what will happen when he loses the waterfront that he has known for as long as he can remember. He requested definite answers concerning impacts to wetland resources and not "I think" or "it could" answers from the applicant and project team.

Carlos Rominicko, resident of 6 Colby Street, an abutter to the project along the Concord River, discussed how he was previously flooded during the fall, winter, and summer but that the river goes back to average water levels quickly unless there are repeated high amounts of rain. He expressed his support of the proposed project.

Deb Folder, 146 High Street, expressed her concern regarding impacts to the Town's water supply and the lack of a Plan B in the event dam removal does impact the Town's drinking water supply.

Diane Smith, 20 Oxford Road, spoke on the project, particularly her concern of the potential project impacts to endangered species of butterflies near the North Billerica Fire Station. She requested confirmation that they would not be affected and Jill Griffith, the applicant's consultant confirmed they would not be affected..

Brian Henderson, 31 Sprague Street, spoke on the project, including the overall benefits to fish and the river. He expressed his support for the proposed project.

Joe Silva, resident of Bridle Road in Billerica spoke on the project and that degree of riverfront in his yard. He expressed his support of the proposed project.

Dave Cook, from Carlisle with the Sudbury Wild Scenic Council, and he also works with OARS, discussed the benefits of the project and his support of the proposed project.

Patrick Robbins, Merrimack Valley Paddling Group spoke on the project and his support of the proposed project.
