- 1) Open mic: None in person, none online.
- 2) Henderson asks members present to submit their preferences for the 2025 Fieldtrip using a matrix-handout. The majority would like to visit Gilson Hill. Members scheduled the field trip for Sunday, January 26 (11 AM till noon), meeting at the (near #105) Rangeway Road parking lot.

She provided a copy of Policies & Procedures, and asked OSRPC members what qualifications they seek for the 9th member Parks liaison: Billerica resident, background in sports league/athletics; arborist; volunteer; landscaping company. Bartlett explains this position is needed because the Recreation Department permits the fields, but Parks maintains the fields; implementation of OSRP is partially Parks' responsibility.
- 5) Malgieri announces that the State has approved the 2025 OSRP. She will forward the letter to the members and print some hard copies.
- 6) Parker reported a Clean Up Green Up (CUGU) / Beautify Billerica gathering (clean-up & meeting). It looks like April 26 will be the date for CUGU. Christina McLaughlin writes the grant for supplies. Malgieri provided a DCR handout listing tree species. Arbor Day is 4/25. Seedling tree giveaways through Massachusetts Tree Wardens (MTWFA)<sup>2</sup> could be on 4/27.
