PROPOSED AMENDMENT to the BILLERICA HOME RULE CHARTER

“Shall the Town Approve the Charter amendment proposed by the Town Meeting as summarized below?”

The proposed Charter amendment approved at the 2024 Spring Town Meeting updates the name change from Board of Selectman to Select Board, clarifies what is required for a petition when implementing Section 2-13 Referendum Procedures, subsection (c) Petition, of the Charter and corrects the timeline for a special election to comply with statutory requirements.

(c) Petition- If within seven days following the dissolution of a representative town meeting, a petition signed by not less than five percent of the voters, containing their names and addresses, is filed with the Select Board requesting that any question as voted by the town meeting members be referred to the voters at large for a final determination, then the operation of any such vote shall be further suspended pending its determination as provided in this section. “We the undersigned voters of the Town of Billerica request that the question as voted under Article (insert number) of the (insert date of meeting) Town Meeting in the form in which it was stated to the Town Meeting by the Moderator, as certified by the Town Clerk, be referred to the voters at large for a final determination.” The Select Board shall, within ten days after the filing of such a petition, call a special election to be held on a date fixed by it not less than thirty-five days later for the purpose of presenting such question to the voters for final determination.
