Call to Order 6:00 PM

The Pledge of Allegiance was recited.

Chairman Burrows called the meeting to order and stated that the meeting is hybrid via Zoom.

1. Reorganization of the Select Board

Chair Burrows opened up nominations for Chair.

<u>MOTION</u> - Member Pavidis made a motion to appoint Michael Rosa as Chair. The motion was seconded by Member Favreau and voted 4-0-0. Member Favreau voted Present.

Chair Rosa thanked the board for their support for Chair. He welcomed Member Pavidis and Member Darris-O'Connor and thanked all candidates who ran. It's not an easy thing to do. It's nice to have people run for positions but it's not easy. His priority as Chair is to have us work together for the benefit of Billerica and operate at a high level of professionalism. He will welcome discussion on diverse ideas but it has to be with respect and civility for each other. This is a new day and new Board and he is confident that they will excel and will benefit the residents.

Chair Rosa opened up nominations for Secretary.

<u>MOTION</u> - Member Darris-O'Connor made a motion to appoint Jillian Pavidis as Secretary. The motion was seconded by Member Favreau and unanimously voted 5-0-0.

Chair Rosa opened up nominations for Vice Chair.

<u>MOTION</u> - Chair Rosa made a motion to appoint John Burrows as Vice Chair. The motion was seconded by Member Favreau and voted 2-2-0. Chair Rosa and Member Burrows voted in favor, Secretary Pavidis and Member Darris-O'Connor voted opposed and Member Favreau voted Present. The motion failed.

<u>MOTION</u> - Secretary Pavidis made a motion to appoint Daniel Darris-O'Connor as Vice Chair. The motion was seconded by Member Darris-O'Connor and voted 2-3-0. Secretary Pavidis and Member Darris-O'Connor voted in favor, Chair Rosa, Member Burrows and Member Favreau voted opposed. The motion failed

<u>MOTION</u> - Chair Rosa made a motion to appoint John Burrows as Vice Chair. The motion was seconded by Member Burrows and voted 2-2-0. Chair Rosa and Member Burrows voted in favor, Secretary Pavidis and Member Darris-O'Connor voted opposed and Member Favreau voted Present. The motion failed.

<u>MOTION</u> - Chair Rosa made a motion to appoint John Burrows as Vice Chair. The motion was seconded by Member Borrows and voted 2-2-0. Chair Rosa and Member Burrows voted in favor, Secretary Pavidis and Member Darris-O'Connor voted opposed and Member Favreau voted Present. The motion failed.

Chair Rosa stated that we cannot come to an agreement on Vice Chair so we will move on without one.

<u>Christopher Tribou of 13 Bridle Road</u> – Mr. Tribou congratulated Secretary Pavidis and Member Darris-O'Connor and it set a clear message. It's not easy to run for an elected office and you should figure out the Vice Chair position. He also thanked Ms. Conway and Mr. Riley for their years of service. He thanked Mr. Main and wished him luck.

<u>Michael Riley of 46 Bedford Street</u> – Mr. Riley congratulated Secretary Pavidis and Member Darris-O'Connor and thanked their families. The Town Manager's search is underway and there should be a policy on how Board members interact with the Town Manager. On Parker Street, the Town Manager should meet with the neighbors and get the article to Town Meeting. Mr. Riley thanked Mr. Main.

<u>John Kearns of 11 Parker Street</u> – Mr. Kearns congratulated Secretary Pavidis and Member Darris-O'Connor and he sorry to see Mr. Main go. On the Parker Street gate, the speed bumps need to be done correctly and we need to look at the idea of 3-way stop signs.

MOTION - Member Darris-O'Connor made a motion to approve the National Grid 3 phase riser - #31061903 – (250 Treble Cove Road) - National Grid proposes to install a new 3 phase riser at new pole 68-50 and install ~10' of 4-4" conduits from pole 68-50 to edge of public way to accommodate relocation of underground electric facilities for the Town of Billerica at Billerica Water Treatment Plant off River Street Extension. The motion was seconded by Member Favreau and unanimously voted 5-0-0.

New pole will be on Town property with a condition that no work be done between October 19-26, 2025. The motion was seconded by Member Favreau and unanimously voted 5-0-0.

Michael Parker joined the meeting. He would like to congratulate Secretary Pavidis and Member Darris-O'Connor and all the candidates who ran. <u>MOTION - Secretary Pavidis</u> made a motion to approve the one-day special alcohol license for the Billerica Public Library Foundation for the Annual Wine Tasting on Friday, April 25, 2025 from 6:30 PM to 9:00 PM located at 15 Concord Road. The motion was seconded by Member Favreau and unanimously voted 5-0-0.

<u>MOTION</u> - Member Darris-O'Connor made a motion to waive all fees. The motion was seconded by Member Favreau and unanimously voted 5-0-0.

15. <u>Approval of a One Day Special Alcohol License and Entertainment License for KHD Inc. dba High Octane</u> <u>Harley Davidson located at 1 Chelmsford Street on Saturday, April 26, 2025 for Motorcycle Stunt Show</u> <u>from 11:00 AM to 6:00 PM</u>

Cameron Fazekas from KHD Inc appeared for the request for an entertainment license and one-day beer and wine license for a motorcycle show on April 26, 2025. Mr. Fazekas stated that this will be a stunt show. We are installing fans to help with smoke. We have overflow parking and local vendors. We expect 100-200 people. We are also limiting people to 2 beer maximum and there will be police and fire details. He understands the impacts of police with smoke and noise. We are asking for grace.

Secretary Pavidis read the email from Chief Frost.

Chair Rosa stated that you have never done an event like this. The video he watched, the show was at a commercial area which is very different from here. He has always supported Harley Davidson events but burn out pits are a different story. There are residents that are near this business, so he would not support this.

Member Favreau asked if there were modifications after the February emails. Mr. Fazekas replied that all changes to plan were based on the updates. Member Favreau stated that you are expecting 100-200 people. Mr. Fazekas replied yes. Member Favreau asked what the expected revenue was. Mr. Fazekas replied it's hard to say, most of the activity is going to be outside. Member Favreau stated that we have been having extensive discussion on helping small businesses.

Member Darris-O'Connor stated that he agrees with Chief Frost. There are residential abutters and right on Boston Road. He does support local businesses but also supports the residents. He will not support a burn out pit.

Member Burrows stated that this will affect Wu Loon Ming. He has no problem with wheelies but doesn't agree with a burn out area.

Secretary Pavidis stated that she agrees with Member Burrows.

Chair Rosa stated that he would agree with the one-day beer and wine and entertainment less the burn out pit. Mr. Fazekas agreed that there would be no burn out pit.

<u>MOTION</u> - Secretary Pavidis made a motion to approve the one-day beer and wine license for April 26, 2025 for KHD, Inc. dba High Octane Harley Davidson from 11:00 AM to 6:00 PM. The motion was seconded by Member Favreau and unanimously voted 5-0-0.

<u>MOTION</u> - Secretary Pavidis made a motion to approve the one-day entertainment license for April 26, 2025 for KHD, Inc. dba High Octane Harley Davidson from 11:00 AM to 6:00 PM with the condition that there is No burn out pit. The motion was seconded by Member Favreau and unanimously voted 5-0-0.

The motion was seconded by Member Favreau and unanimously voted 5-0-0.

<u>MOTION</u> - Secretary Pavidis made a motion that the Select Board accept the \$300 donation and future authorize expenditure of the gift per MGL, Chapter 44, Section 53A to be used for programs and events. The motion was seconded by Member Favreau and unanimously voted 5-0-0.

Chair Rosa stated that Ms. Albertson has asked that we hold off on this.

19. <u>Discussion and Possible Vote to Approve the Axis Security System As A Proprietary Item for the Billerica Recreation Center Project</u>

Mr. Main stated that this is the same security system at the Howe School, Police Station, PHR and High School. This system is tied into the Police system.

Chair Rosa stated that this does not fall within the normal bid process. This will need to be designated as a proprietary item.

<u>MOTION</u> - Secretary Pavidis made a motion that the Axis Security System is a proprietary item for the Billerica Recreation Center project. The motion was seconded by Member Burrows and unanimously voted 5-0-0.

Chris Sennott and Dan Burns joined the meeting. They are looking for permission to clean up and decorate the area around the Revolutionary War Memorial in advance of the ceremony. Mr. Sennott encouraged volunteers to join. Mr. Burns stated that they will be planting flowers also.
