Project Summary: Please provide a brief description of the project. The Town recently completed a Historic Properties Survey Plan which was prepared by Preservation Consultant Wendy Frontiero. Funding the plan provides an opportunity to investigate the potential historical importance of many properties and areas which do not currently have historic status or protection. In accordance with the recommendations of the consultant's plan the Billerica Historical Commission is requesting CPA funding in the amount of \$33,500, to complete the identified Level 1* Priorities as specified in appendix D of the Survey Action Plan (The 67-page survey action plan is available on the Town website and the priorities can be found in the appendix D.).						
Additional funding requests will follow on a three to five-year basis, as the Commission addresses the other areas that have been designated in the survey plan. This would be a level funding approach which would ensure completion of the remaining Priority 1 areas followed by the less urgent Priority 2 and 3 areas.						
This is a unique opportunity as the Billerica Local Inventory of Historical Places has not been upgraded for thirty years. It would be a shame not to take advantage of the recommendations put forward in the current survey action plan.
