# Open Meeting Law Complaint Response from Town Council

The Town's Attorney has spoken with Chair Ventresca and Vice-Chair Burns and reviewed the complaint and documents. Chair Chris Sennott stated that he had received and reviewed the attorney's letter to the state. Diana Saunders noted that there was no Open Meeting Violation, that the complaint was all nonsense, and that there was no good reason to have wasted the town's money on the attorney. Chair Sennott stated that the issue is closed, we need to move forward, and wants no further discussion. (Letter attached.)

#### Subcommittee Structure

Chair Sennott opened the floor for discussion to change the designation of subcommittees to the Working Group, which would avoid the requirement to post meeting agendas and minutes and meet a quorum. Discussion ensued.

Mary Leach of Beautify Billerica announced that the Clean-Up Green-Up is on April 26 from 10:00 a.m. to 12:00 p.m. She stated that several Billerica Historical sites have been added to the list of clean-up sites. Bay State Baptist has committed to helping but needs a Clean-Up Captain to bring supplies and remain on-site to guide.

A motion was made and seconded to participate as a Committee during the Clean-Up Green-Up. Discussion ensued. Several members committed to creating and captaining a clean-up crew. On April 13, the 250th Committee will meet on the Common to clean up before the April 18 Events on the Common. Dan Burns will clean up the Asa Pollard site with a crew. The 250th Committee will share the signup form on its website.

# 4-18 Wreath Laying on Common

Member Tommy Tringale asked if the 250th Committee could lay a wreath on 4-19 before the Farmer Company marched to Concord. Discussion ensued. Vice-Chair Burns stated that the Billerica Colonial Minutemen and the Billerica Historical Society are already making a wreath, pole capping, reading of the 14 Patriots who died, and a brief history of Billerica's Minutemen. A motion was made and seconded to conduct a gathering at 5:00 am on 4-19 with a prayer service and ringing of the church bells.

The motion passed 9-0-1

Tommy also requested that the 250th Committee contact the Museum of the American Revolution to request the loan of a musket used by the Billerica Minutemen at the Battle of Bunker Hill during the Revolutionary War.

A motion was made and seconded to investigate the costs and logistics of the loan.
