- Bill Wiggins would like to see if we can have the stop sign installed coming down Dove Path right before intersection with Hibiscus Path Section 21A. Would also like to donate spruces.

Fred Russell is going to consult with the Engineering Department to see if there is a proposed layout that we can look into for placing benches that make sense in order to avoid placing benches without any order. We also discussed limitations on the number of benches that can be placed per section and all must be of the same standards.
