#### 4 FFY2026-2030 TRANSPORTATION IMPROVEMENT PROGRAM AMENDMENT #2

- **Billerica - Yankee Doodle Bike Path Construction (Phase 1)**  
This amendment programs \$7,370,699 in funding for Phase 1 of the Yankee Doodle Bike Path onto the FFY2026 Statewide Transportation Improvement Program (TIP).
- **Billerica - Yankee Doodle Bike Path Construction (Phase 2)**  
This amendment changes the TIP year of Phase 2 of the Yankee Doodle Bike Path from FFY2027 to FFY2028 and decreases the project value from \$11,780,902 to \$11,252,116.
- **Dracut - Improvements at George Englesby Elementary School (SRTS)**  
This amendment changes the TIP year of this project from FFY2029 to FFY2028, and increases the project value from \$4,465,215 to \$4,820,419.
- **LRTA - FTA Low-No-Emission and Bus and Bus Facility Grant Award**  
This amendment programs \$7,158,564 in funding to the FFY2026 TIP for the LRTA's Low-No-Emission and Bus and Bus Facility Award from the Federal Transit Authority.
